#### **JOHNS HOPKINS STUDY PROVES PATIENT HARM**

- Patients receiving treatment from fraud and abuse perpetrators
  - up to 22% higher mortality
  - up to 30% higher rushed to ER
  - 6700 premature deaths
- Fraud and abuse perpetrators disproportionately treat
  - minority, disabled and low-income Medicare beneficiaries

- Unnecessary chemo drugs
- Untold pain and suffering
- 2 known deaths

- Massive overbilling for Lucentis
- Torturous laser procedures
- Falsified records

## Fake COVID tests seized at airport

Bust in San Diego among latest actions by officials nationwide at ports of entry.

At the Los Angeles Port of Entry in March, a parcel at the international airport's mail facility was labeled "Purified Water Vials," according to Customs and Border Protection. After further inspection, officers found vials filled with a white liquid and


The FDA issued a warning about scams surrounding the pandemic in general,

- "Keep Them Alive as long as Possible"
- CEO: "Help me make my revenue quota"
- Alzheimers, dementia, limited mental capacity patients
- 6 months to live; sent chaplains to give last rites
- Kept others on hospice for multiple years



#### SOCAL HOTBED FOR HOSPICE FRAUD

- Majority for-profit
- Make false promises
- Victims denied healthcare
- 84 y/old Elias: pharmacy declined his medications
- 76 y/old Michael: Forced to pay \$1328 out of pocket for leg brace
- 70 y/old Margarito: denied heart surgery



- 96,000 malicious websites
  - Modernatx
  - Regeneronmedicals.com
  - Remdesivir
- Phony Moderna website allegedly sells COVID-19 vaccines
- Counterfeit COVID-19 vaccine
  - Dark web: \$4000 for empty vaccine vials


